INFORMATION ABOUT CHILD CARE

Types of Child Care

Registered Family Day Care: Care is for up to 6 children and 2 before and after school-age children. The provider's children count in the group size until they attend Kindergarten. There must be one



caregiver for every 2 children under the age of two. Registered providers are registered through NYS Office of Children and Family Services. They must have background checks for criminal and child abuse histories. Their homes are inspected for health and safety. The provider must receive 30 hours of training every 2 years.

Group Family Day Care: Care is for up to 12 children and 4 before and after school-age children. The provider's children count in the group size until they attend Kindergarten. There must be one caregiver for every two children under the age of two. Group providers are licensed through NYS Office of Children and Family Services. They must have background checks for criminal and child abuse histories. Their homes are inspected for health and safety. The provider must receive 30 hours of training every 2 years.

<u>Legally Exempt Family Child Care</u>: Care is not regulated but is legal care. The provider can care for up to 2 children who are not related to them. If the care is under 3 hours per day more children are allowed.

<u>Legally Exempt In-Home</u>: Care is provided in the child's home. The providers are considered an employee of the family and are exempt from licensing.

<u>Day Care Center</u>: Care is licensed and in a public non-residence space. Centers are inspected for health and safety; providers receive background checks and training. Centers may be accredited by the National Association for the Education of Young Children. Classrooms are divided by age groupings; infants, toddlers, preschool and school-age. Age groups do not mix in centers.

THAT'S A GOOD POINT

THINGS TO THINK ABOUT WHEN LOOKING FOR QUALITY CHILD CARE

Group Size— Think about your child. Does he/she like to be in larger or smaller groups of children? Would your child enjoy being in a setting with children of different ages or children who are all about the same age? Look at the different types of care, age groupings, and the number of children in the group.

Caregiver Education- Each regulated child care provider must meet specific educational requirements to become registered or licensed. Each regulated program must have at least one person who is certified to perform first aid and CPR. They must also receive training every 2 years in developing their program, child abuse and maltreatment identification, reporting and prevention, program development, nutrition, child development, shaken baby syndrome prevention, health & safety and NYS regulations.

Caregiver Turnover- Children who have on-going care with the same provider learn to trust and build strong relationships. When child care arrangements fall apart often it is difficult for the child. It important to try to set up arrangements that will last for the benefit of the child. It is good to ask how long a program has been in business and how long the adults have worked there to determine if it may be a long term arrangement.

Family Involvement- Programs must allow parents to drop in at any time. Programs should have a system for communicating with parents to share information about the child's day. The communication between the provider and the parent is extremely important to your child.

Health and Safety- Choosing quality child care that focuses on health and safety eases a parent's fears. NY State regulations require that adults and children wash their hands frequently, diaper changing areas are cleaned and disinfected after each child and fire drills are performed monthly. NYS has created regulations to keep children safe and healthy; they include doing background checks on the adults working in child care. Ask your child care provider how your child will be kept safe and healthy.

Average Weekly Cost of Care in Ulster County- According to our information from child care providers in Columbia, Greene and Ulster Counties, program fees range from \$145-\$270 per week, depending on the type of care and the age of the child. When choosing a program, be sure to be aware of whether or not meals and snacks are included in the cost of care. Ask about late fees, sibling discounts, sliding scale fees, employer supports and pre paid discounts. Ask your program about their policies on absences, vacations, holidays and if payment is required during these conditions. Answers to these questions can affect the yearly cost of care.

Nutritional Resources

Nutrition: CACFP (Child and Adult Care Food Program) is a program that enables the child care program to serve nutritious meals and snacks to the children in care without passing on the cost to working parents.

<u>Farmers Markets</u>: Promote improved nutrition by eating more locally grown fresh fruits and vegetables. The New York State Farmers' Market Nutrition Program (FMNP) provides checks to low-income, nutritionally at-risk families enrolled in the Special Supplemental Nutrition Program for Women, Infants, and Children (WIC) and Senior Nutrition Programs.

<u>School Age Child Care</u>: Is registered care for children kindergarten through age 12 before and/or after school. Some programs offer care when school is not in session.

Summer Camp: Receives a permit to operate from the State or County Health Department. Camps must be in compliance with health department regulations. They are inspected twice a year with at least one inspection taking place while children are present.

<u>Nursery School</u>: Is not regulated care. Children must attend less than 3 hours per day. They are considered exempt from licensing. They may choose to register with NYS Education Department and meet a higher standard.

<u>Universal Pre Kindergarten (UPK)</u>: Is a program through NYS Education Department. Local school districts may offer UPK in the school or in another setting, such as a Child Care Center. UPK is less than 3 hours per day.

Head Start: Is a federally funded program. The full day programs must be licensed as a Day Care Center. The program is primarily for very low income families. The program works with the entire family, focusing on education, health, parental involvement and social services. Below is a sample of the income guideline. Each County in NYS has separate guidelines.

Tax benefits for Parents may include the Child and Dependent Care Tax Credit

If you paid someone to care for a child or a dependent so you could work, you may be able to reduce your tax by claiming the credit for child and dependent care expenses on your federal income tax return. This credit is available to people who, in order to work or to look for work, have to pay for child care services for dependents under age 13 or if you paid for care of a spouse or a dependent of any age who is physically or mentally incapable of self-care.

The Federal and State Earned Income Tax Credits (EITC) are refundable tax benefits for working people with low or moderate incomes. Workers who qualify for the EITC and file Federal and State tax returns can get back some or all of the income tax that was withheld during the year.
